23/132 Councillors Reports

Cllr. Preece:

- Cllrs Mehta and Preece and the local residents group working with T&WC to improve safety on Lightmoor Road
- Avon Close, Little Dawley, drains are now unblocked
- Horsehay & Lightmoor Borough Councillors Pride Fund money has been allocated for pot hole repairs in Spring Village
- Idverde have commenced their Spring maintenance programme cutting hedges and bushes in the Parish
- Police working with T&WC to combat speeding on Wellington Road and the surrounding Horsehay roads

Cllr. Mehta:

- T&WC are taking a tougher stance on prosecuting fly-tippers

- PC Brittain had emailed the Parish Council to ask if we would like the police to hold a 'pop in' surgery in the Parish. Councillors were keen and had suggested two locations, Horsehay Village Hall car park and the pharmacy car park on Majestic Way in Aqueduct at the end of the school day, we have asked for surgeries at both locations and we are waiting further information

23/134 Updates From Local Nature Reserve Friends Groups in the Parish

Cllr, B Wennington issued a report for Dawley Hamlets LNR in advance of the meeting which was circulated to Councillors and presented at the meeting by Cllr. S Wennington, it included:

- A lot of falling trees over the winter which have been dealt with by T&WC
- Plants and trees starting to grow and there are grebes on both the Furnace and the Sump pools
- The walkway is still too flooded to use
- The Wednesday group has returned to help keep the woods tidy but are now the Tuesday group, funding from the Friends Group has enabled the project to keep going
- Soon there will be some more new fishing pegs on the Wide Waters
