17/145 Chairman's Opening Remarks

The Chairman welcomed all to the meeting.

17/146 Apologies

Apologies were received from Cllr. C Tranter.

Courtesy apologies were received from Borough Councillors J Greenaway and R Mehta.

The Chairman informed the meeting that Cllr. C Salter had tendered her resignation. The resignation was accepted by the Council and it was agreed that flowers and a card would be sent to Cllr. C Salter to thank her for her work on the Parish Council.

17/148 Public Session

This item was included in the Annual Parish Meeting which was held immediately prior to this meeting.

17/149 Councillors Reports

This item was included in the Annual Parish Meeting which was held immediately prior to this meeting.

17/150 To Confirm the Minutes of the Previous Meeting

Cllr. Scott proposed to accept the Minutes of the Meeting held on 21st March 2018 as a true record, this was seconded by Cllr. Hopkins and AGREED by the Council. The minutes were signed by the Chairman.

17/151 Local Initiatives:

a) Un-adopted Road at Spring Village

Cllr. Hopkins shared the feedback he had received so far from the questionnaires received back from Spring Village residents. It was agreed that Cllr. Hopkins would collate all the responses and a letter would be drafted to T&W Council's highways department regarding the issues concerning the road and surrounding area together with the findings from the survey.

Cllr. Hopkins left the meeting at 8.00pm.

b) To consider the gardening scheme SLA

The Chairman explained the details of the proposed SLA for the gardening service with Great Dawley Town Council and the matter was discussed at length by the Council. The Chairman proposed to accept the SLA for this year and review in November whether to continue, this was seconded by Cllr. Wennington and AGREED by the Council. Three members of the Council abstained from the vote.

c) Telford@50 Picture Gallery

The Clerk explained that she and Cllr. Cooke had collected together a number of suitable pictures for the gallery. It was AGREED that £700 would be spent on the gallery and that the final pictures would be selected by Councillors at the next working group meeting on Monday 23rd April 2018.

17/152 Parish Matters:

a) Site of the now closed All Labour in Vain Public House

The Council were informed that David Jones, T&W Councils Principal Enforcement Officer, had visited the site in response to the Councils concerns and e-mailed a response which the Chairman shared with meeting. As it appeared that development of the site would be starting shortly it was AGREED that no action was currently needed but the situation would continue to be monitored.

b) New Grounds and Cleansing Contract Questionnaire

The Clerk informed the Council that the questionnaire had been completed and circulated to Councillors by e-mail. It was AGREED that any further comments should be forwarded to the Clerk by Monday 23rd April 2018 at which time the questionnaire would be submitted to T&W Council.

c) Provision of Additional Grit Bins

The Clerk informed the Council that three requests for grit bins had been received so far:

- 1. 42-44 Avon Close, Little Dawley
- 2. Wellington Road, Myford
- 3. Chapel, Horsehay

The Clerk said she had contacted the Council who said that they would only pay for the bins if they meet their relevant criteria. It was AGREED that these three additional bins were required and that the Clerk would see whether they meet T&W Councils criteria otherwise they would be funded by the Parish Council.

d) Feeding the Wildlife at Horsehay Pools

The Clerk informed the Council that an article on the correct feeding of wildlife called 'Breaducation' had been included in the newsletter and that there was a local initiative in place organised by C J Wildlife and the Shropshire Wildlife Trust to provide signs around the borough and visit schools to promote correct feeding information. It was AGREED that the Clerk would invite Lisa Veale from CJ Wildlife and Julie Burrows from the

Shropshire Wildlife Trust to the next Parish Council meeting to talk about the initiatives, how they could benefit the Parish and how the Parish Council could become involved.

e) Newsletter and Summer Picnic Update

The Clerk informed the Council that Cllr. Wennington was in the process of proof-reading the newsletter, it would be printed next week and delivery would commence Saturday 27th April.

The Clerk informed the Council that the catering, hall, entertainer and St. John Ambulance had all been booked for the Telford@50 Summer Picnic and that she had obtained a party pack from T&W Council. It was AGREED that Cllr. Onions would supply the table decorations with a budget of £60 to do so.
