No matters were raised during the public session.

- **18/139 To Confirm the Minutes of the Meeting Held on 20th February 2019.** It was proposed by Cllr. Scott, seconded by Cllr. Onions and **RESOLVED** to approve the Minutes of this Meeting as a true record. The minutes were signed by the Chairman.

18/141 Integrated Community Management Scheme (PCSO)

The Chairman raised a concern regarding suspicious activity at one of the parish car parks which had been brought to her attention, it was agreed that the Clerk would raise the matter with the PCSO.

18/142 Councillors Reports:

The Chairman, Parish Councillors and Borough Councillor Greenaway gave verbal reports to the meeting. Cllr. Onions updated the meeting on the latest Bus User Group meeting, Cllr. Pinter had attended CSE awareness and the Idverde open day.

18/143 Local Initiatives:

a) Dawley Hamlets Local Nature Reserve

Cllrs. Cassar, Scott and Wennington updated the meeting on the progress of the Friends of Dawley Hamlets Local Nature Reserve group which included the first two events planned for the 7th and 8th of June and the success of their T&WC Community Events Grant application for which they have been awarded £475.00. Councillor Scott notified the meeting that the Friends Group bank account had now been set up. It was **RESOLVED** that the Parish Council would match fund Cllr. Andy Burford's Pride Fund contribution of £1,380.84 to Dawley Hamlets Local Nature Reserve and that this would be paid over to the Friends Group together with Counciller Jane Pinter and Borough Councillor Steven Barnes' pride fund contributions and match funding, totalling £6,661.68.

18/144 Parish Matters:

a) Idverde Grounds Maintenance Contract

The Clerk presented a short report to update the meeting on the progress of negotiations with Idverde in preparation for them replacing TWS on the 1st April, she said that she had met with Paul Smith representing Idverde on the 1st March and confirmed that all decisions made by the Council at the February meeting regarding the new contract had now been put in place.

It was **RESOLVED** to award £1,000 to sponsor the annual Horsehay Horticultural Society show (Cllr. Onions abstained from voting).
